

In terms of provisions of Regulation 30 (read with Part A of Schedule III) and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations), this is to inform you that the National Green Tribunal (NGT), vide its order dated 10/08/2023 (Order) has directed the Company and its subsidiary, namely, Yerrowda Investments Limited (subsidiary) to deposit an amount of Rs. 9.06 crores towards Environmental Damage Compensation (EDC) with Maharashtra Pollution Control Board (MPCB) within a period of 2 months from the date of uploading of the Order. Further, MPCB has been directed to examine and take necessary action in the matter.

The above order has been passed in respect of raising additional construction of commercial building 'Creaticity' (earlier known as 'Ishanya'). The Environment Clearance dated 20.7.2020 for total Built Up Area (BUA) has been upheld by the NGT.


