Broad commercial consideration or size of the order(s)/contract(s)	Petronet LNG will regasify approximately 25 TBTUs of LNG annually, post an initial ramp-up period, primarily at its Dahej terminal. The Size of the Contract in value terms is Rs. 1200 Crore with an additional outlay of upto 20%, over the contract duration
